## Why Business Analysts Matter

# Keys to Success

#### Subject Matter Experts ≠ Business Analysts

"Business Analysts provide pivotal communication with user stakeholders for specific knowledge of business processes to be supported via IT. Rarely does the BA already have such specific knowledge through direct experience. They are good communicators, however (or should be), and can gain the necessary specifics via a series of joint application design (JAD) sessions with stakeholders or through other requirements techniques." ~ Gartner

#### Business Analyst's Scale, Subject Matter Experts Don't

"Situating BAs in the BUs (Business Unit) leads to "parttimers" who come and go as the BUs' project demands fluctuate. Having a team of BAs dedicated to the role not only helps manage fluctuating project demands, but also drives BAs to achieve greater capability. They can support, teach and learn from one another, and build practices that they have in common with a

Center of Excellence."

#### **Prescribe Outcomes NOT Implementation**

The deliverable – the requirements document – must be fit for use by the system delivery team. BAs are "translators" of business needs into IT requirements; they need to be fluent in the language of technology systems and they need to provide the requirements detail necessary to guide real system delivery work while maintaining focus of the outcome of the business need. ~ Gartner

## How To Do It: The BA Transformation

- To encourage business analysts to begin thinking in strategic terms, organizations should:
  - Foster a culture that encourages problem identification and creating solutions.
  - Ensure business analysts have the opportunities to learn leading-edge techniques.
  - Give business analysts the opportunity to participate and contribute to strategic conversations.
  - Encourage certification through the IIBA.
